### MAYOR'S REPORT

Mayor Gorden thanked the Jewish Federation for hosting a breakfast for all public officials in Cuyahoga County. Mayor Gorden stated that the Jewish Federation hosts this event yearly and the purpose of the breakfast is to make sure everyone mixes and mingles with all elected officials so that the Jewish Federation knows who is representing them. Mayor Gorden stated that many officials from all over the County were present.

Mayor Gorden stated that the Mayors and Managers Association gather monthly and the meeting last month was held at NASA. Mayor Gorden stated that he was so impressed with what the NASA facility means to all of us, not just Clevelanders in this region. Mayor Gorden stated that he has been there several times over the years and the technology that they employ and what they are doing as far as spacecraft and how they are changing propulsion and the technology is truly amazing. Mayor Gorden stated that there will be an Open House in mid-May that is free to the public and he urges everybody to attend. Mayor Gorden stated that he is aware that the students often go to NASA. NASA in Cleveland is the only facility that is studying ice formation on engines and propulsion.

### COUNCIL MEMBERS (NON-AGENDA ITEMS)

Mr. Isaacson stated that he attended Entrovation on Saturday, April 30<sup>th</sup> along with other members of Council and it was a great event and wonderful opportunity to see what the members of the schools are doing and everyone who is participating in the marketing program which is a multi-school system venture that Beachwood hosts and it is a great example of what the up and coming go-getters are doing. Mr. Isaacson stated that it is a wonderful example of how the schools are working with other communities in order to offer new and innovated programs.

Mr. Pasch stated that he attended both the Jewish Federation breakfast as well as Entrovation and first on the Jewish Federation breakfast it is tremendous to see the impact that Jewish officials are having in this County and in the greater northeast Ohio area and having the ability to come together once a year is a tremendous experience and although it is a quick breakfast it is good to be in the same room as everyone else for a limited amount of time. Mr. Pasch stated regarding Entrovation, he would like to thank everyone in the City who helped with the schools. Mr. Pasch stated that Mrs. Carmen was there all day. Mr. Pasch stated that you see kids from all over the region such as Beachwood and West Geauga, they are our future leaders and it is great to see them begin before they go on to do tremendous things in the coming years.

Mr. Jacobs stated that the breakfast at the Jewish Federation this morning was not just for Jewish officials but officials from all over Cuyahoga County including officials from the State of Ohio.

Mr. Horwitz thanked the City employees from the Service Department and Mrs. Carmen's department for their work on the PTO Garage Sale.

Mr. Berns stated that the PTO Garage Sale collected approximately \$14,000.00.

DEPARTMENT DIRECTORS

Mrs. Carmen thanked Council for the comments regarding Entrovation. Mrs. Carmen stated that there were approximately 3,500 people in attendance at Entrovation which was held on April 30<sup>th</sup> from 11:00 A.M. until 6:00 P.M. Mrs. Carmen stated that the 43 students participating in Entrovation have set a record for scholarships of 4.1 million dollars. Mrs. Carmen stated that eight area schools participated in Entrovation; Brush, Beachwood, Mayfield, Aurora, Solon, Orange, West Geauga, and Chagrin Falls.

Mrs. Carmen stated that before the next Council meeting they will be celebrating Older American's Month and calling them seenagers, they are teenagers plus 60 years. Mrs. Carmen stated that there will be events throughout the month of May which the Federal government has designated as a salute to older Americans.

Mrs. Carmen stated that May 11<sup>th</sup> is Muffins with the Mayor, and Sunday, May 15<sup>th</sup> is Shred Day from 9:00 A.M. until Noon, rain or shine in the parking lot.

Mrs. Carmen stated this coming weekend is the production for the spring called 13 The Musical which talks about young people coming of age. The musical kicks off Friday, May 6<sup>th</sup> at 7:30 P.M., Saturday May 7<sup>th</sup> at 4:00 P.M., and Sunday, May 8<sup>th</sup> at 2:00 P.M. at the Beachwood Middle School.
