4. DISCUSSION REGARDING REVIEW OF STORMWATER ORDINANCES

The Summary of Proposed Stormwater Management Code Revisions, included with the meeting agenda, explains the proposed revisions to the City's Stormwater Ordinances.

The definition of stormwater was discussed as well as the need for the City to update ordinances pertaining to stormwater.

There are three proposed ordinance updates, while one existing ordinance (Chaper 1173- Illicit Discharge and Illegal Connection Control) will remain unchanged.

Proposed updates to Chapter 1157 Riparian and Wetland Setbacks include the addition of both permitted and prohibited uses for riparian and wetland areas to comply with federal and state level changes.

Proposed chapters 1175 and 1177 were previously one chapter. The proposed updates separate them.

Chapter 1175 Erosion and Sediment Control is new and will deal with construction related items, i.e. keeping sediment from construction sites out of state waterways.

Chapter 1177 Comprehensive Stormwater Management is updated and addresses both stormwater quality and quantity, including post construction control measures.

At this time, a motion was made to move the proposed Ordinance updates to the April 6, 2020 City Council Meeting.
