

## GARAGE SALE PERMIT APPLICATION – CHAPTER 713

To the Building & Community Development Director:

An application is hereby made for a permit to conduct a sale of personal property, as so described in this statement, and all accompanying data, all of which are made a part of this application.

- An application for a permit shall be made at least three (3) days prior to the date proposed for the holding or conducting of such sale.
- Garage sales are limited to one per year per house.
- A garage sale is permitted during the hours of 10:00 a.m. to 7:00 p.m., and not to exceed three consecutive days.
- A sign, not to exceed four (4) square feet, may only be placed in the front yard of a residence where a permitted sale is being held. No sign shall be placed on any part of a City street right of way, including the tree lawn, or on any tree or utility pole thereon. (Section 713.09 Signs)
